Inaugurating the new premises of the [Kelso Institute Europe \(KIE\)](#) in Kreuzberg Str. 76, Berlin the Kelso Professorship has extended its reach.

Founded in late 2020 the KIE facilitates a sustainable Energy Transition with a focus on consumer (co-)ownership in renewables, and broadening employee financial participation.

[The Louis and Patricia Kelso Fellowship](#) was awarded for the first time to Dr Riccardo Novo of Politecnico di Torino who then joined the KIE as research coordinator for Renewable Energy & Engineering.

Two new pieces by Mrs Kelso, on [Democracy in the Age of the Internet](#) and [The Role of Truth in a Democracy](#) were published.

**H2020 SCORE:** The Final Report "[Consumer Stock Ownership Plans \(CSOPs\) – Financing Energy Communities](#)" is available online on the [SCORE website](#).

Continuing innovation research on Energy Communities we are launching an [online Morphological Box tool](#) enabling researchers and policy makers to identify best practice and "blank spots", i.e., constellations underused. A [brand new article in Energy Policy](#) provides the background.

**Energy/electricity sharing** is another focus of our ongoing research. To provide continued support to our SCORE "Follower Cities" we develop a **value sharing concept**.

**Wind In My Backyard - WIMBY:** Our new [Horizon Europe project](#) exploring barriers to social acceptance of wind power projects kicks-off in January. The KIE develops guidelines to raise public understanding and implement engagement strategies for citizens across ten countries.

**FinSESCo:** Since May we work on end-to-end digitalisation of energy

contracting and intracting to facilitate consumer participation in energy efficiency.

**Research agenda until 2030:** The KIE and the Kelso Professorship support a fair and equitable Energy Transition. Investigating how the 2030 targets and the transition to climate neutrality by 2050 affect the RECOVER fields of delivery we postulate a **Just Circular Society**.

**New project proposals include:** Support for Energy Communities (under review); "Just Transition to climate neutrality" and "[Developing a sustainability investment CSOP](#)" (under development).

We much look forward to continuing our cooperation with you.
